## **Board of Commissioners Called Meeting**

### **Minutes**

**November 2, 2017**

**6:00 PM**

**Mayor Burgess welcomed everyone. Commissioner Efird, Commissioner Broadway, Commissioner Huneycutt, Commissioner Harvey and Commissioner Little were present for meeting. Also present were Mayor Burgess and Patti Efird, Town Clerk.**

**Mayor Burgess informed everyone that we need to set a Public Hearing for the purpose of a text amendment in regards to signs. The Board discussed this.**

**Commissioner Huneycutt made a motion to set a Public Hearing for November 20, 2017 at 7:00pm for the purpose of amending the text to Article VIII, Section 14 of Oakboro's Zoning Ordinance to increase the size and height of signs in the H-B zoning district from 20 feet to 30 feet and to allow a larger per sign allowance. Commissioner Little seconded the motion and it carried.**

**Mayor Burgess told the Board that there are 5 dead trees at the Oakboro Cemetery that need to be cut down and some trimming to be done from entrance to the back. He has a quote for this work for \$2,100.00 from Jason's Tree Service.**

**Commissioner Efird made a motion to have dead trees cut down at the Oakboro Cemetery with trimming the overhanging trees at a cost of \$2,100.00 by Jason's Tree Service. Commissioner Little seconded the motion and it carried.**

**The Commissioners discussed future ideas for the cemetery and Oakboro Sign. Mayor Burgess said he would get quotes on various projects.**

**After discussion, it was agreed that Preston Flowers will be allowed an unpaid internship with the Town of Oakboro during the next semester.**

**Commissioner Harvey made a motion to go into Closed Session. Commissioner Broadway seconded the motion and it carried.**
