Department Updates:

Police Department: Chief Smith reported that they had 194 calls to service, 570 business and neighborhood checks, 6 arrests and 86 citations.

Water and Sewer: Commissioner Huneycutt - No Report

Advisory Board/Code Enforcement: Commissioner Efird: He reported that the Planning and Zoning Board continues to have problem with not having enough members for a quorum. This past Tuesday night they had two Public Hearings and not enough members showed up to vote. The hearings had to be rescheduled. He requests that the Board appoint Chief Smith to the zoning board as a "regular inside member" and appoint himself as an "alternate". Also, he stated that he had repeatedly called Gus Vanegas but gets no answer. Commissioner Harvey stated that she would call Mr. Vanegas and have him come to the next Planning and Zoning meeting.
