

BOARD OF COMMISSIONERS MINUTES

December 19, 2022 Organizational Meeting 7:00 PM

Mayor Little called the organizational meeting to order.

Mayor Little welcomed everyone and asked the assistant town clerk to read the "Abstract of Votes" from the regular election that was held on November 8, 2022. Mrs. Leslie Murray read the voting results as follows:

For Mayor:

Lisa Cratty received 266 votes, Chris Huneycutt received 478 votes and Robert (Bobby) Watkins received 89 votes.

For Commissioners:

Brett Barbee received 470 votes, Joey Carpenter received 358 votes, Lee Huntley received 169 votes, Latoya Jackson received 439 votes, Charles (Chip) Osborne received 123 votes, Bud Smith received 455 votes and Fred Smith received 199 votes.

Next, the assistant town clerk swore in Mr. Chris Huneycutt as mayor, Mrs. Latoya Jackson as commissioner and Mr. Brett Barbee as commissioner. Each raised their right hand and placed their hand on the Bible held by someone special to them and repeated the oath. Afterwards, they took their seats.

Mayor Huneycutt welcomed everyone and asked the assistant town clerk to do the roll call. Commissioners Barbee, Hathcock and Jackson were present. Mr. Burgess was also present. Commissioner Smith was absent.

Mayor Huneycutt called on Pastor Jonathan Waits for the invocation.

Mayor Huneycutt entertained a motion to appoint Commissioner Barbee as Mayor Pro-Temp. Commissioner Jackson made a motion to appoint Commissioner Barbee as Mayor Pro-Temp and Commissioner Hathcock seconded. Voted and carried unanimously by all commissioners present.

Mayor Huneycutt entertained a motion to approve the agenda as printed. Commissioner Barbee made a motion to follow the agenda as written. Commissioner Jackson seconded. Voted and carried unanimously by all commissioners present.

Mayor Huneycutt appointed the commissioners to the different departments.

Mayor Huneycutt entertained a motion to appoint Leslie Hatley-Murray as town clerk & finance officer. Commissioner Barbee made a motion to appoint Mrs. Murray as town clerk and finance officer. Commissioner Jackson seconded. Voted and carried unanimously by the commissioners present.

Mayor Huneycutt entertained a motion to appoint Mr. Doug Burgess as town administrator. Commissioner Hathcock made a motion to appoint Mr. Burgess as the town administrator and Commissioner Jackson seconded. Voted and carried unanimously by all commissioners present.

Mayor Huneycutt entertained a motion to appoint Mr. Albert Benshoff as town attorney. Commissioner Barbee made a motion to appoint Mr. Benshoff as the town attorney and Commissioner Jackson seconded. Voted and carried unanimously by all commissioners present.

Mayor Huneycutt stated it was time for the clerk's oath of office. Being a notary, Mrs. Murray's father, Mr. Larry L. Hatley swore in Mrs. Murray for the town clerk and finance officer position. Mayor Huneycutt stated the board also needed to authorize Mrs. Murray to be added to the account as town clerk and finance officer allowing her to be able to sign the checks. A motion was made by Commissioner Jackson and seconded by Commissioner Barbee. Voted and carried unanimously by all commissioners present.

Mayor Huneycutt referred to the meeting schedule for 2023 and entertained a motion to adopt this schedule. Commissioner Barbee made a motion to adopt the meeting schedule for 2023 and Commissioner Hathcock seconded. Voted and carried unanimously by all commissioners present.
