

BOARD OF COMMISSIONERS MINUTES August 19, 2024 7:00 PM

Mayor Huneycutt called the meeting to order. He asked Mrs. Leslie Murray, Town Clerk, to call the roll. Commissioner Brett Barbee, Commissioner Joey Carpenter, Commissioner Lanny Hathcock, Commissioner Latoya Jackson, Commissioner Bud Smith and Ms. Georgia Harvey, Town Administrator were present. Mr. Reggie Bowers and Mr. Daniel Smith were also present.

Commissioner Smith had the devotion for tonight's meeting.

Approvals

Mayor Huneycutt entertained a motion to approve the agenda. Commissioner Smith made a motion to approve the agenda. Commissioner Barbee seconded. Voted and carried unanimously.

Mayor Huneycutt entertained a motion to approve the minutes of July 15, 2024 & July 29, 2024. Commissioner Carpenter made a motion to approve the minutes and Commissioner Jackson seconded. Voted and carried unanimously.

Mayor Huneycutt entertained a motion to approve the accounts payable in the amount of \$294,037.19. Commissioner Jackson made a motion to approve the accounts payable. Commissioner Barbee seconded. Voted and carried unanimously.

Administration

Mayor Huneycutt referred to Ms. Harvey for any administrative updates. Ms. Harvey informed everyone that the SRO started today at Oakboro Choice STEM School. The SRO is Jennifer Antonucci with the Stanly County Sheriff's Department. She also informed everyone that the police chief job was posted along with the utility billing specialist position. Those were posted last Wednesday.

Commissioner Barbee made a motion to scale up the minimum pay to \$20/hour for our parks and recreation department and adjust the ones who have been here accordingly. Commissioner Carpenter seconded.

Cemetery & Streets

Mayor Huneycutt referred to Commissioner Carpenter. Mr. Carpenter called on Mr. Reggie Bowers to share. Mr. Bowers shared after the storm we had, the department had to put stone on the roads again where it has washed away. They also had some debris to remove after the storm. Mr. Bowers told the board the department had been cleaning out ditches as well.

Police Department

Mayor Huneycutt called upon Commissioner Lanny Hathcock. Commissioner Hathcock referred to Interim Chief Jason Eschert. Interim Chief Eschert presented the following information:

Parks and Recreation

Mayor Huneycutt called upon Commissioner Jackson. Commissioner Jackson referred to Mr. Daniel Smith. Mr. Smith shared that the soccer practices have started. He mentioned that almost all ball fields are busy this time of year with the Oakboro Youth League using the baseball/softball fields as well as the soccer practices going on. Commissioner Jackson asked if there were any flyers for the movie in the park and Mr. Smith stated there will be soon and that Sunny Day Markets has already created a Facebook event for the Fall Festival at the park.

Public Works

Mayor Huneycutt called upon Commissioner Smith. Commissioner Smith asked Mr. Reggie Bowers for an update. Mr. Bowers shared the following information about the water and sewer departments:

Water

- Installed several new meters
- Repaired 2" water line
- Located water lines for 811
- Jordan Jackson has helped Mr. Bowers with the Wellhead Protection Program and also set up at the last cruise in to show the citizens what this encompassed. The town received the approval letter for the Wellhead Protection Program which will give the town 5 extra points which comes in during the application process for various grants. Brochures are available at town hall regarding the Wellhead Protection Program.

Sewer

- Weekly and monthly checks on the sewer pump stations
- Repairs on many E-1 pumps
- I & I work and found several leaks to correct that.
- Chambers Engineering is proceeding for the McCoys Creek Outfall Line. On September 5 there will be a bid opening for this.
- Located sewer lines for 811

Mayor Huneycutt referred to Commissioner Hathcock who asked Ms. Harvey for an update. Ms. Harvey had nothing to report from the Planning and Zoning board meeting; however, she wanted to talk to the board about street and alley closures. Commissioner Hathcock made a motion to suspend any applications at the present time regarding the street and alleyway closures. Commissioner Barbee seconded. Voted and carried unanimously.
