**Commissioner Little approved the Accounts Payable in the amount of \$46,703.83. Commissioner Broadway seconded the motion and it carried, unanimously.**

**Parks and Recreation – Commissioner Efir: He recognized Parks Director, Josh Almond. Mr. Almond reported that the usage at the parks remains high. They’ve had several tournaments. He also reported that they’ve put up 3 cameras at the park and have 6 more to go. Mayor Burgess reported that the bridge needs repair and he will get estimates.**

**Water and Sewer – Commissioner Huneycutt – no report**

**Advisory Board/Code Enforcement – Commissioner Efir: He reported that he was pleased to announce that David Heath had agreed to join the Planning and Zoning Board.**

**Commissioner Harvey made a motion to appoint David Heath as a member of the Oakboro Planning and Zoning Board. Commissioner Efir seconded the motion and it carried, unanimously.**

**Commissioner Huneycutt made a motion to add 30 additional parking spaces at Oakboro’s District Park. Commissioner Harvey seconded the motion and it carried, unanimously.**

**Commissioner Efir made a motion to go into Closed Session to discuss personnel matters. Commissioner Little seconded the motion and it carried, unanimously.**

**Commissioner Little made a motion to go back into Open Session. Commissioner Broadway seconded the motion and it carried, unanimously.**


